**PETITION FOR PRE-SUIT DISCOVERY TO INVESTIGATE
POTENTIAL CLAIMS AND REMEDIES PURSUANT TO RULE 202**

TO THE HONORABLE JUDGE OF THIS COURT:

COMES NOW CITY OF PLANO, TEXAS, a home-rule Texas municipality, (“City”), pursuant to Rule 202, Texas Rules of Civil Procedure and files its Petition for Pre-suit Discovery to Investigate Potential Claims and Remedies, and would show the Court the following:

I. INTRODUCTION

The City of Plano brings this action to conduct pre-suit discovery for investigation of potential claims seeking injunctive relief, civil penalties, court orders, attorneys fees, and all other available remedies to stop and prevent **TENNYSON WELLNESS CENTER** and/or **DIANA ZHANG** (“Respondents”) from engaging in or allowing illicit activity, criminal conduct, and/or lewd behavior, including Prostitution and Indecent Assault, being perpetrated under the guise of a massage establishment. Pretending to operate as a legitimate health-care provider in the midst of other businesses frequented by innocent citizens and children, Respondents’ sale of sex acts creates a dangerous environment and public nuisance. Cloaked behind the façade of a licensed massage establishment in a medical and business complex at 6541 Preston Road in Plano, Respondents have failed to comply with statutory regulations and

legitimate practices designed to prevent sex crimes, attracting clientele who exploit women and may engage in deliberate deceptive measures to prevent exposure of their debauchery and criminal conduct.

The citizens of Plano are entitled to seek legitimate health care and other services for themselves and their families without unknowingly leading their children past a brothel or parking next to predators willing to purchase the bodies of women. Criminal prosecution of Respondents' employees for sexual offenses and state regulatory enforcement has been insufficient to protect the public, demonstrating a willingness to profit from the sex trade and flagrantly ignoring risks to the community.

The City of Plano is committed to putting an end to prostitution and other sex crimes that threaten law-abiding citizens and children, including using all available means to uncover profiteers as well as purchasers. Respondents have deceived citizens who mistakenly assume that the sale of sex only occurs in an obviously seedy establishment or part of town with visible streetwalkers, but the Tennyson Wellness Center is a sex broker hiding in plain sight. Respondents' sex workers and their corrupt consumers lurk among legitimate businesses, including health-care providers for children. So that potential respondents can be identified, testimony and other evidence can be preserved, consumers of the illegal activities be identified, and appropriate remedies can be pursued for protection of Plano's citizens and visitors, the City is seeking an order from the Court authorizing pre-suit discovery pursuant to Rule 202, Texas Rules of Civil Procedure.

During pre-suit discovery, the City will vigorously investigate Respondents, owners of the business(es), property owners, landlords, managers, operators, employees, contractors, predecessors, successors, transferees, customers, clients, co-conspirators, accomplices,

promoters, invitees, guests, and all other parties to illegal or illicit activity (“Potential Litigation Respondents”). The City intends to take depositions orally and by written questions, request issuance of subpoenas duces tecum for and production of business and financial records, employee and customer records, and compliance with Texas law for massage establishments pursuant to Chapter 455, Texas Occupations Code, the statutory regulations governing massage establishments and massage therapy and authorizing a Texas municipal attorney to seek injunctive relief, civil penalties, court orders to prevent violations, and recovery of expenses.

II. FACTUAL BASIS AND REASONS FOR SEEKING RULE 202 DISCOVERY: PERSISTENT PATTERN OF IMPROPER AND CRIMINAL CONDUCT

1. CRIMINAL CONDUCT

On two different dates this year, Plano Police arrested employees of **TENNYSON WELLNESS CENTER**, located at **6541 PRESTON ROAD, SUITE 200, PLANO, COLLIN COUNTY, TEXAS**, for sexual crimes, including Prostitution and Indecent Assault, committed at **TENNYSON WELLNESS CENTER** while massage therapy was supposed to be performed. At the time of both arrests, **DIANA ZHANG** was identified as an owner, director, managing member and person with care, custody, or control over the business.

On February 23, 2023, Plano Police arrested **QIAOYU ZHANG** at **TENNYSON WELLNESS CENTER** for **PROSTITUTION**, a criminal offense in violation of Sec. 43.02, Texas Penal Code. **QIAOYU ZHANG** claimed to be a citizen of China and resident of Flushing, New York with a Driver License issued by the State of New York, while working as a massage therapist in Plano, Texas for Respondent. Respondent **DIANA ZHANG** was named as an owner, director, and managing member of Respondent and was working with **QIAOYU ZHANG** at the premises at the time of the prostitution arrest.

Respondents have knowingly failed to take steps to prevent further sex crimes at the business and continued to hide behind the façade of a legitimate health-care provider. On September 7, 2023, Plano Police arrested **TIFFANY SONG** at **TENNYSON WELLNESS CENTER** for **INDECENT ASSAULT**, a criminal offense in violation of Sec. 22.012, Texas Penal Code. Also working for Respondent with **TIFFANY SONG** at the time of the second offense was **DIANA ZHANG** (named as owner, director, and managing member of Respondent and also present at the same location when **QIAOUY ZHANG** was arrested for Prostitution) and **HONG ZHANG**, identified by a customer as offering a sex act for payment of money on the same date as the Indecent Assault.

2. COMPLAINTS FROM CITIZENS.

On multiple occasions in January and February, 2023, law enforcement received numerous complaints from citizens that massage therapists employed by Respondent inappropriately touched customers and offered to perform sexual acts in return for money. At the time of the arrest of **TIFFANY SONG** for Indecent Assault on September 7, 2023, a customer of **HONG ZHANG** provided information to Police that he had received offers of sexual acts for payment of money from **HONG ZHANG** and other employees while receiving massage services at **TENNYSON WELLNESS CENTER**. Previously, Texas Department of Licensing and Regulation (“TDLR”) had received a complaint from a citizen who said he was charged for sexual acts that he did not request, and Respondents’ employee refused to refund the money for those sexual acts. TDLR inspectors also observed finger condoms at the premises, and Respondent **TENNYSON WELLNESS CENTER** received a warning for the violation of the regulations in Chapter 455 of the Texas Occupations Code. In March 2023, TDLR issued a

warning to Respondent **TENNYSON WELLNESS CENTER** for not maintaining records as required by state regulations for massage establishments.

3. CLOSE PROXIMITY TO LEGITIMATE BUSINESSES AND HEALTH-CARE PROVIDERS FREQUENTED BY THE PUBLIC.

Located in a business complex in Plano, Respondents' illicit massage establishment is engaging in sex crimes in a busy suburban area. This is the seemingly innocent façade:



In this very same complex as **TENNYSON WELLNESS CENTER**, there are dental offices, including a pediatric dentist, a medical office specializing in obstetrics and gynecology, an ophthalmologist, an oral surgeon, an office for orthopedics and sports medicine, an infectious disease medical office, a facial and plastic surgery center, a heart treatment center, and other businesses, including law offices, a construction and design company, and a certified public accountant. Appearing on the outside to blend in with legitimate health-care providers, **TENNYSON WELLNESS CENTER** is little more than a front for criminal activity, in close proximity to lawful medical providers frequented by the unsuspecting public, including children. In fact, **TENNYSON WELLNESS CENTER** promotes its location as a “**MEDICAL CENTER**” in online advertising, as depicted in EXHIBIT NO. 1.

4. DANGER TO THE PUBLIC AND SEX REVIEWS

Those who frequent **TENNYSON WELLNESS CENTER** for the purchase of vulnerable women’s bodies brag in anonymity and share reviews of the sex crimes for sale. Attached hereto as EXHIBIT NO. 2 are copies of representative online reviews of the sex acts and women available for sale at **TENNYSON WELLNESS CENTER**. The online reviews of women being purchased at **TENNYSON WELLNESS CENTER** contain demeaning evaluations of their bodies, including breast size, “ass rating”, and pubic area. The women are given “service ratings”, like twisted Yelp reviews from those deviants who purchase their bodies in this self-described “medical center”. Reviewers provide graphic descriptions of sex acts purchased from prostitutes at **TENNYSON WELLNESS CENTER**. Some reviews require membership fees paid to the online review database, but others are readily available to anyone in the public searching online for reviews of **TENNYSON WELLNESS CENTER**. Respondents can hardly pretend the advertising and online presence for **TENNYSON WELLNESS**

CENTER projects an image of a wholesome and legitimate massage establishment. It is abundantly clear that Respondent advertises itself with salacious images of scantily clad employees and provocative poses. Attached hereto as EXHIBIT NO. 3 are copies of representative advertising by Respondent, including the following example:



5. PERSONS TO BE DEPOSED, SUBSTANCE OF ANTICIPATED TESTIMONY, AND REASONS FOR OBTAINING TESTIMONY OF EACH

- c. **CCH REAL ESTATE, LLC**, registered agent for service of process and managing member, Christine Hopkins, at 6541 Preston Road, Suite 100, Plano, Texas 75024 or 4600 Oak Shores Drive, Plano, Texas 75024;
- d. **PRESTON COMMONSGATE CONDOMINIUM**, registered agent for service of process, Lance E. Williams, 3811 Turtle Creek Boulevard, Suite 500, Dallas, Texas 75219; Bryan Kerns, President and Director, 6533 Preston Road, Suite 300, Plano, Texas 75024 or 6529 Preston Road, Plano, Texas 75024.

The substance of the testimony to be elicited from Respondents **D & R NUTRITION AND WELLNESS LLC DBA TENNYSON WELLNESS CENTER** and **DIANA ZHANG** is exhaustively detailed in the foregoing paragraphs, but essentially, to ascertain information about their compliance with applicable laws and statutes authorizing massage establishments and prohibiting criminal conduct and public nuisances. The substance of the testimony to be elicited from **CCH REAL ESTATE LLC** and **PRESTON COMMONSGATE CONDOMINIUM** is the scope of their knowledge of the operations and activities of Respondents, their ownership of the premises where Respondents are engaged in improper and/or illegal activities, their business relationship with the Respondents, and other matters pertinent to the investigation and possible claim or suit which may be filed against Respondents - and perhaps others.

The likely benefit to the public of allowing the City to take the requested depositions to investigate potential claims far outweighs the burden or expense of the procedure, particularly since – as detailed above – the Respondents are engaged in a scheme of illicit and illegal behavior which is substantially detrimental to the health, safety and wellbeing of the public. It is unknown at this point if the property owner(s)/landlord(s) are complicit in this illicit and illegal activity, or rather, merely pocket the rent money and then turn a blind

eye to the obvious sale of sex on their property. Under either scenario, it seems surprising that a legitimate owner/landlord would knowingly allow the sale of sex to be permitted on their property, particularly in a medical center frequented by families and children.

III. PARTIES

1. Petitioner, **CITY OF PLANO**, is a home-rule Texas municipal corporation located in Collin and Denton Counties, Texas.
2. Respondent, **TENNYSON WELLNESS CENTER**, is located at **6541 Preston Road, Suite 200, Plano, Texas 75024**. Respondent can be served through its registered agent or wherever they may be found.
3. Respondent, **DIANA ZHANG**, is an individual residing in Collin County, Texas, and can be served at 3537 Pillar Drive, Plano, Texas.

IV. JURISDICTION AND STATUTORY AUTHORITY

Under Texas Rule of Civil Procedure 202, venue is proper in this county because venue of the anticipated suit is in Collin County, Texas. *See* Tex. R. Civ. P. 202.2(b). This Court has jurisdiction over these matters pursuant to the appropriate sections of the Texas Constitution, the Texas Civil Practice and Remedies Code, and the Texas Occupations Code. This Petition for Pre-Suit Discovery to Investigate Potential Claims and Remedies arises out of activities and conduct occurring within Collin County, Texas, making this Court an appropriate forum for venue of this action.

Chapter 455 of the Texas Occupations Code (“Occupations Code”) provides statutory authority for remedies designed to protect the public in the provision of massage therapy. The conduct and licensing of massage therapists, massage schools and instructors, and the licensing and operation of massage establishments are regulated as a Health Profession in Chapter 455.

The statute authorizes the City Attorney to seek injunctive relief against any person who appears to be in violation or is threatening to violate Chapter 455, including court-ordered requirements to prevent further violation. Chapter 455 authorizes assessment of civil penalties of \$1,000 – \$10,000 for each violation, and every day of occurrence is a separate violation. Chapter 455 further provides that the City may recover reasonable expenses in obtaining injunctive relief and civil penalties, including court costs, attorneys’ fees, investigative costs, witness fees, and deposition expenses.

V. SELECTION OF DISCOVERY LEVEL

1. Petitioner intends to conduct discovery under Level 2 of the Texas Rules of Civil Procedure 190.3 because this suit involves only monetary relief aggregating not more than \$100,000, excluding court costs and pre-judgment interest, and Plaintiff affirmatively pleads that this suit is not governed by the expedited actions process in Texas Rule of Civil Procedure 169.

VI. CONCLUSION AND PRAYER FOR RELIEF

For the reasons stated above, Petitioner the City of Plano respectfully requests the Court, after service of this Petition and notice, to hold a hearing on this Petition pursuant to Tex. R. Civ. P. 202.3(a), issue an order authorizing the City to take the depositions of the persons identified herein as well as authorizing the City to issue subpoenas requiring these entities and/or persons to produce documents at their depositions.

WHEREFORE, PREMISES CONSIDERED, the City of Plano respectfully prays:

1. That Respondents be cited and required to appear herein;
2. That the Court set a date for this matter to be heard;

3. That the Court authorize pre-suit discovery/depositions as requested herein; and
5. Any and all other relief, at law or in equity, to which the City of Plano may show itself to be justly entitled.

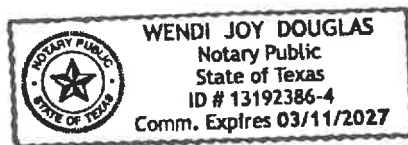

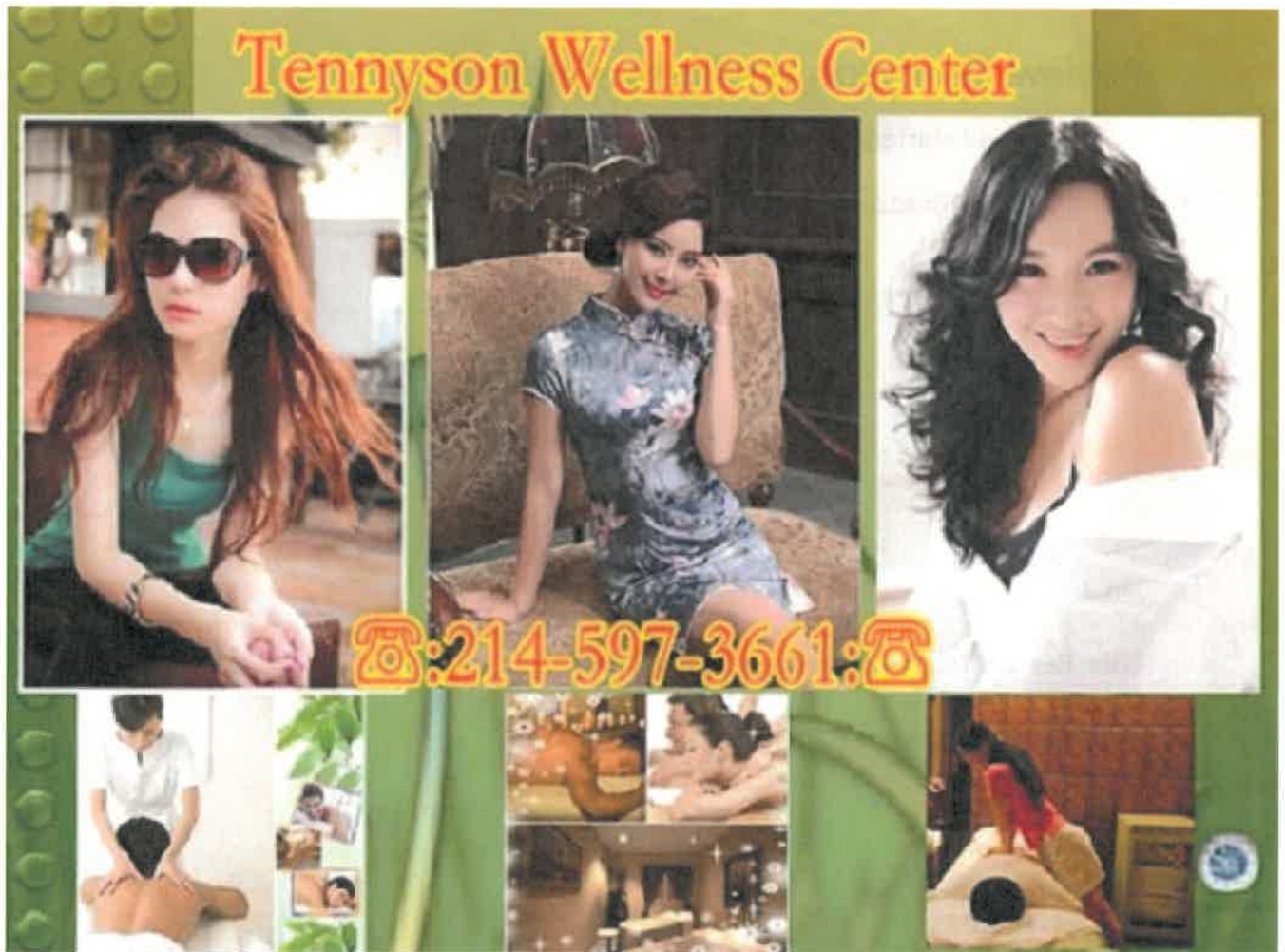


