- No exemption will be approved until proper documentation has been received.

Reason for Exemption

School LST		Multiple Employers: Attach a copy of a current pay statement from your principal employer that shows the name of the employer, the length of the payroll period, and the amount of Local Services Tax withheld. <i>List all employers on the reverse side of this form</i> . You must notify your other employer(s) of a change in principal place of employment within two (2) weeks of the change.
Municipal & District L		Active Duty Military Exemption: Attach a copy of your orders directing you to active duty status. Annual Training is not eligible for exemption. You are required to advise the tax office when you are discharged from active duty status. Military Disability Exemption: Attach a copy of your discharge orders and a statement from the United States Veterans Administrator documenting your disability. Only 100% permanent disabilities are recognized for this exemption.
Municipal LST ⁽¹⁾		Expected Earned Income and Net Profits from all sources within (municipality) will be less than \$ (threshold amount from reverse side): Attach copies of your last pay statement or your Form W-2 for the prior year. If you are self-employed: Attach a copy of your PA Schedule C, F, or RK-1 for the prior year.

Employer: Once you receive this Exemption Certificate and the required documentation, you shall not withhold the Local Services Tax for the portion of the calendar year for which this certificate applies, unless you are otherwise notified or instructed by the Tax Collector to withhold the tax.

Note:

- 1. The municipality is required by law to exempt LST from individuals whose income from all sources (employers and self-employment) in their municipality is less than \$12,000 when the LST rate levied exceeds \$10.00.
- 2. The school district for the municipality where your worksite is located may or may not levy an LST. If it does not, the income exemption may differ from the municipality and can range between \$0 to \$11,999.
- 3. All information received by the Tax Collector is considered confidential and is only used for official purposes relating to the collection, administration, and enforcement of the Local Services Tax.
