- ____ 1. **PLOT PLAN/SITE PLAN** shall be provided for all construction projects.
- ____ 2. **PROOF OF OWNERSHIP:** Recorded Deed. Contact the Ingham County Register of Deeds at (517)676-7216.
- ____ 3. **SOIL EROSION AND SEDIMENTATION** permit must accompany application if your project is within 500 feet of a lake, body of water, stream or county drain. Contact Public Service 483-4455.
- ____ 4. **ONE SET OF CONSTRUCTION DRAWINGS.** Include:

An addition or improvement to an existing residential structure that is in a floodplain where the construction is equal to 50% or more of the original value requires approval from the City of Lansing's Construction Board of Appeals prior to issuance of a building permit per section R105.3.1.1 of the Michigan Residential Code.

I understand it is the legal responsibility of the applicant to call for all required inspections as indicated on the plan review. No Electrical, Plumbing, Mechanical or structural components shall be concealed until approval has been granted. Separate permits shall be required for all Electrical, Mechanical and Plumbing installations throughout the project.

I understand Public Act 230, Section 10 requires that I obtain a building permit prior to starting construction and Section 13 of the Act requires that I obtain a Certificate of Occupancy from the Building Safety Office prior to occupying a structure in part or in full.

An investigation fee, in addition to the permit fee, shall be collected whether or not a permit is then or subsequently issued. The payment of such investigation fee shall not exempt any person from compliance with all other provisions of the Code nor from any penalty prescribed by law.
