Permit Fee: \$286.00 City of Bakersfield accepts cash, check, Mastercard or Visa

Deposit: Based on the amount of work involved in Right of Way. Types of deposits include: Cash, Credit Card (\$5000 limit on credit cards), Checks, Bond (100% Performance and 100% Labor & Materials Bonds, based off of the Engineer's Estimate) or Letter of Credit.

Insurance: 1. Homeowner: Personal liability insurance in the amount of \$300,000.00 or

Degradation Fees: These are to be expected when cutting into asphalt paving in good existing condition.

Engineer's Estimate: May be required whenever work involves new asphalt paving or overlay.

Street Permits expire 120 days from date of issue. Time extensions must be made prior to expiration with Rider.

Rider Fee: \$29.00 Cancellation fee: \$91.00 Additional Inspection Fee (after the first two): \$93.00 per hour.
