

# ALEXANDRIA REAL ESTATE EQUITIES, INC. INVITES YOU TO TWO VIRTUAL COMMUNITY INFORMATION MEETINGS

Please join Alexandria Real Estate Equities, Inc. (ARE) for a review and discussion on conceptual plans for the Watertown Mall and adjacent parcels that are controlled by ARE. The purpose of these meetings will be to present and discuss ARE’s proposed plans to redevelop the Watertown Mall area into a collaborative and innovative campus including life science, retail and community uses, as well as publicly accessible open spaces and streetscape improvements.

The discussion will highlight a master plan special permit concept, conceptual designs for the new buildings and the associated public realm including pedestrian and bicycle connectivity to the adjacent neighborhoods. *(note: postings will be available online on the Town website prior to the first meeting)*

We will be hosting two community information meetings: one on **January 27th**, and the other on **March 1<sup>st</sup>**. Please join us for one or both evenings. The first meeting will provide the full project presentation; the second will briefly review project details and will address any additional details or follow-up questions from the first meeting.

In light of the COVID pandemic, the meetings will be conducted virtually via Zoom. Prior to the start of each meeting, please access the links below to join via computer or mobile device. You may be instructed to download the Zoom application. The project team will also attempt to secure a live broadcast spot with local cable access TV.
