CANDIDATE ELIGIBILITY REQUIREMENTS	DEADLINE TO FILE CANDIDATE APPLICATION**	
<ol style="list-style-type: none"> <li>Must be a United States Citizen</li> <li>Must be a registered voter on the date of election</li> <li>Must be a resident of the City of Plano for one (1) year prior to the date of the election</li> <li>Have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated; or partially mentally incapacitated without the right to vote</li> <li>Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities</li> <li>Must satisfy any other requirements prescribed by law or City Charter for the office</li> <li>Candidates must be nominated by petition per City Charter and state law: <a href="#">City of Plano Code of Ordinances</a></li> <li>Application*, Petition* and Nomination Form must be filed together by the filing deadline</li> <li>Candidate Packets are available in the City Secretary's Office the first week of January in odd years. <b>Candidates are strongly encouraged to obtain a candidate packet.</b></li> </ol>	February 14, 2025 by 5:00 PM
