Are you interested in paying for your permit fees online using a credit card? Follow these simple steps to start paying your fees online!

*Note: Maximum transaction allowed is set at \$10,000 or per your agreement with your credit card company (whichever is less). Contact Planning and Development if you need to make a payment exceeding this maximum.
