

TERMS OF USE

PAYMENT: The named responsible party agrees to pay any fees due according to the card issuer agreement. (Merchant agreement if credit voucher).

CUSTOMER ACCOUNTS: Accounts are limited to one per household. Multiple accounts will be combined.

CAMPGROUND RESERVATIONS & CHECK-IN: A reservation for Jalama Beach Campground may be made for one (1) site per household, per stay. A reservation for Cachuma Lake may be made for up to three (3) sites per household, per stay. Campground Campers may not make reservations for other parties, and reservations may not be transferred to anyone outside the household. The license plate number of the primary vehicle must be entered at the time the reservation is made. Reservations will be verified upon check-in with license plate and/or ID. The person whose name and address appears on the reservation must be present.

CANCELLATIONS, CHANGES & REFUNDS: Reservations cancelled within 24 hours of making the reservation are eligible for a full refund. A reservation for camping must be cancelled a minimum of three (3) calendar days in advance of the reservation/check-in date in order to receive a refund, less a \$20 cancellation fee per site and the non-refundable reservation fee. All fees paid will be forfeited if a reservation is cancelled less than three (3) calendar days prior to reservation/check-in date. All reservations are rain or shine unless cancelled or changed at least (3) calendar days prior to reservation/check-in date. Refunds will be made to the person whose name and address appears on the reservation. Changes to confirmed camping park reservations must be requested at least three (3) calendar days in advance of the check-in date. Camping Park reservations may be extended (subject to availability), and shortened by changing the departure date only. Due to the popularity of our camping sites and facilities and the six-month advance limit, reservations may not be shortened by changing the check-in date. Reservations may be changed or moved (date, site, or park) a maximum of 2 times. Additional changes will be subject to additional reservation and cancellation fees.

SPECIAL USE/EVENTS: Authorized use of reserved area(s) includes the provided amenities within the site reserved. Prior authorization and special permitting from CSD or other departments may be required for weddings, memorial services corporate and other special events. A Special Event is an event that impacts, encroaches or infringes on the surrounding group areas, and or requires the use of more than the provided amenities. Unauthorized events may result in additional fees or eviction. Please call the Parks Administration office at (805) 568-2460, Option 5 if you think your use could be a special event.

LIABILITY AGREEMENT: The named responsible party on the reservation agrees to accept the condition of the County property described above as is and agrees to defend, indemnify and hold harmless the County of Santa Barbara, its officers, agents and employees from all liabilities, claims or losses for personal injury (including death) or property damage arising from the activity described above. The same party further agrees to hold harmless the County of Santa Barbara, its officers, agents or employees from any liabilities, claims or losses arising from the Applicant's personnel or property connected in any way with the activity described above. The responsible party also agrees to repair, replace or repay (including attorney's fees) the County of Santa Barbara for any damage to County property in connection with said activity. The above party is responsible for observing all the rules, regulations and special requirements pertaining to this event. This agreement shall be binding upon the above-named requestor, organization or company, their heirs, successors or assigns.

IMPORTANT: Any abuse or violation of these terms will result in the automatic cancellation of reservations and loss of fees.
