- 3. Place your completed Statement into your own envelope with sufficient postage. Mail, deliver, or have your completed statement delivered to the elections official.
- 4. If you do not wish to send your completed Statement by mail or have it delivered, you may submit your completed Statement by email to <a href="Votebymail2@countyofsb.org">Votebymail2@countyofsb.org</a> or fax it to 1 (805) 681-4003 or 1 (805) 568-2209, or submit your completed Statement to a polling place within Santa Barbara County or a ballot drop-off box before the close of polls on Election Day.

  NOTE: Secure Ballot Drop Boxes and Polling Place Locations will close at 8:00 p.m. on Election Day.
- 5. Please note that the signature provided on the completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.
