A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PLANO, TEXAS, AMENDING THE DOWNTOWN DEVELOPMENT PLAN AS ADOPTED BY RESOLUTION NO. 91-9-18(R) AND APPROVING THE USE OF SAID AMENDED PLAN BY THE APPROPRIATE PERSONNEL AND DEPARTMENTS OF THE CITY OF PLANO FOR THE PURPOSE OF GUIDING FUTURE DEVELOPMENT WITHIN DOWNTOWN PLANO; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Plano, Texas desires to provide consistent, clear guidance for the future development of Downtown Plano; and

WHEREAS, toward that end, the City Council formed the Downtown Plano Committee to develop a comprehensive plan to provide direction and guidance on matters relating to land use and development regulation and review, public investment, historic preservation, and the general enhancement of Downtown Plano; and

WHEREAS, on September 11, 1991, the City Council adopted the Downtown Development Plan as presented by the Downtown Plano Committee (Resolution No. 91-9-18(R)); and

WHEREAS, the City Council intends for the Downtown Development Plan to be consistent with current trends and conditions; and

WHEREAS, on October 19, 1992, the Planning & Zoning Commission held a public hearing on proposed amendments to the Downtown Development Plan and at the close of said hearing recommended their adoption; and

WHEREAS, on November 9, 1992, the City Council held a public hearing on these proposed amendments to the Downtown Development Plan; and

WHEREAS, the City Council, having been presented the proposed amendments, a copy of which is attached hereto as Exhibit "A" and incorporated by reference, upon full review and consideration thereof, and all matters attendant and related thereto, is of the opinion that these proposed amendments to the Downtown Development Plan should be approved, adopted, and used by the City of Plano;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PLANO, TEXAS, THAT:

<u>Section I</u>. The proposed amendments to the Downtown Development Plan, having been reviewed by the City Council of the City of Plano and found to be acceptable and in the best interests of the City of Plano and its citizens, are hereby approved and adopted.




FIGURE 10 2 of 2


